Item 4: Acceptance of Minutes of Meeting held 7th January 2016.

Proposed by Councillor Teague and **resolved** that the minutes of the meeting held 7th January 2016 were a correct record of the meeting and the minutes were duly signed by the Chairman.

Item 5: Matters arising from the Minutes of Meeting held 7th January 2016, (not included in this agenda).

5.1 Item 13.1 – Horses galloping on St Hilary Common.

The Clerk advised that she is waiting for a response from the Vale of Glamorgan Council. Councillor Simkiss mentioned a possible 'Protection of Open Space Act' which might apply in this case.

The Clerk advised that she had contacted the Vale of Glamorgan Council to request that the 'Road Sweeper' visits Llandough.

Item 6: Report from the Vale of Glamorgan Councillors.

The Planning Application for Darren Farm had been approved with a considerable number of conditions which will have to be met.

Item 8: Clerk's Report.

Finances

Bank balance was noted at £5,087.93 (Current Account £4,195.77 and Savings £892.16).

Footpath from St Mary Church to The Herberts.

The Footpath Officer, Mr Gwyn Teague, had contacted the Clerk regarding concerns of the Council with horse riders using the footpath. He advised that it is not a specific offense to ride horses on a public footpath, rather doing so may constitute a trespass against the underlying landowner. Mr Teague does offer to arrange the installation of signage indicating that the path is for use by pedestrians only. **Resolved** that the Community Council should accept Mr Teague's offer of signage.

Queen's 90th Birthday Beacon.

Letter received from the Mayor of Cowbridge advising that the Town Council is considering lighting a 'Beacon' on St Hilary Down on 21st April in celebration of the Queen's 90th Birthday. Many beacons were lit across the country in 2012 in celebration of the Queen's Diamond Jubilee and Buckingham Palace is appealing to communities to do this once again this year. The Mayor is seeking support from groups in the community including Llanfair Community Council and intends to hold a meeting shortly to discuss arrangements.

Resolved that Councillor Llewellyn should attend the meeting on behalf of the Community Council and report information back to Members for their consideration.

Item 10: Broadband in the Rural Vale.

Councillor Teague advised that he attended a recent meeting regarding the ongoing broadband issue in St Mary Church. It is intended to have the planning process completed by June with the improved broadband in situ by mid-November. There will be a seven week survey phase. There will be 'poles' erected in the area through Llandough and the public will have an opportunity to object to the process Members of the Community Council will be contacted during the process and there will be an opportunity to walk the route sometime during June/July. The new system will require three boxes situated in Llandough, The Herberts and St Mary Church and the superfast broadband will be able to supply most of the homes in the area.

Item 11: To discuss Christmas Celebrations.

Councillor Llewellyn advised that it has been decided to use the St Hilary portion of the Christmas CASH Grant to purchase 'lights' for the festive season to place on a tree in situ in the centre of the Village.

Item 13: Correspondence and Publications.

- 13.1 Letter received from the Vale of Glamorgan Council in response to the one sent from Llanfair Community Council with regard to fact that paper copies of plans will no longer be posted out to Town and Community Councils. The comments with regard to the provision of broadband in the rural areas of the Vale of Glamorgan are noted but it advises that it is not necessary for plans to be displayed only when connected to the internet as they can be accessed at a location which has a faster connection and saved to a compute or memory stick and then printed out or displayed from the computer's memory. Where it is felt necessary paper copies can still be requested from the Local Planning Authority. Also responses to planning consultations are requested within 21 days. With regard to possible funding concerning the installation of internet connection within the Village Hall, the letter has been forwarded to the ICT Department and it is suggested that enquiries are made with the Welsh Government. Noted.
- 13.2 Letter received from One Voice Wales regarding the annual subscription which is now due renewal at a cost of £70, an increase of £2 on last year. The letter also advises of the services accessible and provided to Town and Community Councils.

 Resolved that the Community Council renews its annual subscription to One Voice Wales at the cost of £70.
