Minutes of **Council** Meeting held at St Hilary Village Hall on Thursday, 5th January 2017 at 7.00pm.

- Item 1: Apologies for Absence. Councillors Heather Shaw and Geoff Simpson. Vale Councillors G A Cox, H Jarvie and A Parker.
- Item 2: Declarations of Interest. None declared.
- Item 3: Community Police Matters. No police presence.
- Item 4: Acceptance of Minutes of Meeting held 1st December 2016. Proposed by Councillor Simkiss and resolved that the minutes of the meetings held 1st December 2016 were a correct record of the meetings and the minutes were duly signed by the Chairman.

Item 5: Matters arising from the Minutes of Meeting held 1st December 2016, (not included in this agenda).

- 5.1 Councillor Teague referred to item 3, telephone scams and advised that he had received two calls on his mobile that day, which were obviously scams.
- 5.2 Members discussed item 14.1, the two benches on St Hilary Down. The wooden/resin bench (in memory of Mr Jack Solomon) is on the part of the Common under the responsibility of the Vale of Glamorgan Council. The Clerk will take a look at both benches before the next meeting.
- 5.3 The adoption of the BT Telephone box in St Hilary (item 14.3). The Clerk advised that enquiries were made with Zurich Insurance and should anyone be injured through use of the box they would be fully covered under the public liability section of the insurance. The box itself would need to have a value placed on it for insurance purposes. It is probable that BT would be able to give the replacement cost of the telephone box.
- 5.4 Item 14.4 the provision of Superfast broadband. Members discussed the location of the green boxes and it is probable that the green box for Llandough will be located in the 'pull-in' area opposite The Mill.

Councillor Hawkins thanked Councillor Simkiss for chairing December's meeting.

Councillor Hawkins advised that he had attended the Morning Act of Remembrance and Choral Evensong for Remembrance Sunday in St Hilary and thanked Councillor Simpson for representing Llanfair Community Council at the Remembrance Parade and Service in Cowbridge.
