Item 1: Apologies for Absence.

Item 2: Declarations of Interest.

Councillor Simkiss – Planning Application No. **2019/00993/FUL** (owner of the

property referred to in the planning application).

Item 3: Community Police Matters.

PCSO Rich advised that there was one burglary in St Mary Church, one 'concern call' and one crime against a person.

Members referred to 'The Farm' and their request for the St Hilary councillors to visit the premises. PCSO Rich agreed to make an enquiry into this request.

Councillor Hawkins advised that he was aware of the theft of a lawn mower from a shed in St Hilary but it would appear that this has not been reported to the Police.

PCSO Rich requested that Members remind the residents to secure their property. The Police are introducing a Rural Watch Scheme whereby Farmers are requested to report any vehicles parked in places which they would not be expected to be parked.

PCSO Rich asked that any suspicious activity be reported to her on her mobile number 07805 301644 or by ringing '101'.

A discussion took place on speeding vehicles on rural roads.

Item 4: To discuss the 'Community Speed Watch Wales' initiative of South Wales Police.

Members referred to the 'Community Speed Watch Wales' and advised that they wish to be involved in the scheme. PCSO Rich detailed some of the criteria and agreed to get the forms to the Members.

Item 6: Matters arising from the Minutes of the Meeting 5th September 2019.

6.1 Item 12.3 – HGV vehicles getting 'stuck' in St Hilary.

The Clerk had contacted Highways at the Vale of Glamorgan Council asking for a meeting for councillors with Highways Officers to discuss the issue. The request had been refused but the Operational Manager asked for detailed information of occurrences and particularly photographs with dates, times and names of companies. A request was made for the 30mph speed signs to be moved to the outskirts of the village in an attempt to slow down through traffic.

6.2 Item 6.1 – Payment for use of Llanfair Primary School for meetings. Councillor Llewellyn had raised this with the Headteacher. Mr Guy has requested dates of meetings which have taken place at the School in order for an invoice to be raised.

Enquiries made had indicated a kiosk currently up for sale at £3,500. **Resolved** that the kiosk should not be insured for 'all risks' and that public liability insurance would be adequate.
