#### Item 10: To Discuss Installation of a Defibrillator in Llandough.

A detailed document has been received from the Llandough Village Community Group giving full details of the project so far. The cost of the project is estimated at £3,197 with £2,197 raised by donations from residents and a contribution from the Community Group.

Members were concerned at the high cost in relation to the installation of the electricity connection from Western Power at £1,406 but this is because the chosen option is to site the defibrillator in the centre of the village feeding from an existing lamp post.

The Members agreed that a site meeting should be arranged to investigate the proposal.

Councillor Bonnar suggested two possible avenues for funding:

- Western Power "In This Together Community Matters Fund".
- Vale of Glamorgan Strong Communities Grants Fund.

The Clerk to write to the Community Group suggesting that applications be made to both funding streams.
