The law comes into play on the 17th September. Signage and enforcement could be a challenge as it is expected that this will not have been fully completed by this time. The Council have been assured that any enforcement (especially in areas where signage is not complete) would be proportionate and that the police are favouring educational methods.

There will be exceptions for A/B Class Roads and these can be reviewed and will be consulted on by the relevant groups. This relates to where there are A/B class roads, in areas that should be 20mph but there can be an exception made to either keep it 20mph or default to another speed limit. A full interactive map should be available on Data Map Wales around mid/end June.
